You are applying for a job at Ferrwood Music Camp as a camp counselor. Please know you will be expected to interact with the children at all times. You will be expected to provide support and encouragement as well as supervision and entertainment. You will be expected to work all day and night with the exception of lesson times which are from 9-11:30 a.m. and ensemble times which are 6-8 p.m. daily. Counselors must be in the dorms with the campers at 10:00p.m. and remain there all night. Counselors are not allowed in the reception room or kitchen during the evening hours after lights out. You are expected to supervise the campers, this is for the safety of all campers and assures counselors get a good night's sleep. Any problems need to be reported to the director or assistant director immediately.

Absolutely no alcohol, tobacco or drugs are allowed on the property of Ferrwood Music camp! Alcohol, tobacco or drugs are not allowed at any time, even if no children are on the premises. Failure to abide by this rule will result in immediate dismissal from camp without pay. Under aged drinkers will be reported to the police as well as their parents, no exceptions. Counselors / Instructors who are of legal drinking age will have a letter sent to their college or university or place of employment. Counselors report directly to the director and assistant director and who will have full authority during the camping season. *Counselors can always challenge a decision made by the director and or assistant director to the President of the Philharmonic who will have the ultimate authority to render a final decision. Proper chain of command must be followed before the President of the Philharmonic is involved.*
